

# **Bus Shelters - Update**

As reported in our September Newsletter by Cllr Redfern, two bus shelters are to be installed near the Oakwood Hotel on A<sub>3</sub>8 and now, following the approval of adoption at the last Parish Council meeting, we are pleased to report that the first of these two Bus Shelters has now been installed, on the A<sub>3</sub>8 Northbound stop.



This will be welcome news for passengers while waiting in this exposed location.

Cllr Redfern has also been following up on the Bus Shelter for Twigworth Green (which is to be provided by the Developer), this is by far the most used Bus Stop in Twigworth but the Bus Shelter is still some way off and the Parish Council have been pushing the Gloucestershire County Council on this for some time.


We have been informed by

GCC, that the Developer, has advised they are out to tender for the Bus Shelter, we will continue to keep chasing this and will report any progress on this.

# **Planning Application - Approval**

#### 24/00050/FUL Bengrove Farm, Base Lane, Sandhurst, GL2 9NU

Tewkesbury Borough Council Planning has granted permission for the installation of a solar farm, internal tracks, security fence, associated infrastructure and landscaping.

There are a number of conditions and measure that must be complied with prior to and during construction works.

## Twigworth Green Road Safety - Update

Following the report in our October Newsletter about road safety issues at Twigworth Green, Cllr Redfern has received a reply from the Gloucestershire County Council (GCC) Highways Legal Agreement Team.

#### A38 Traffic Speed Limit onto Twigworth Green

GCC responded by stating that when Ironbridge Road becomes an adopted highway, maintainable at public expense, a maximum speed limit of 30mph will apply, GCC are liaising with Vistry to install the necessary signage to reflect this.

#### Ironbridge Road/Barley Drive Hazard

GCC responded by stating that the road is yet to be subjected to a Stage 3 Road Safety Audit and will be subjected to one before it is fully adopted highway maintained at public expense. Before this time, any safety concerns should be directed the appropriate developer.

#### Ironbridge Road/Apley Road - Sales Office Roundabout "Blind Spot"

GCC responded by stating that it is still subject to a Stage 3 RSA and safety concerns should be directed to the appropriate developer.

Cllr Redfern has again reported these road safety concerns and GCC responses to Vistry and the Twigworth Green Management Company (Gateway); feedback about these issues, will be shared as and when we have a reply.



#### **Dog Owner Reported!**

There are still one or two serial offenders who walk their dogs at Twigworth Green, who continue to ignore their dog ownership responsibilities and in time, they too will also be identified and reported.
