Order 2005

The Gloucestershire County Council ("the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 20th January 2005 and may be cited as the "Gloucestershire County Council (Various Speed Limits)(Various Parishes within the Tewkesbury Borough) Order 2005"
(ii) This Order affects roads in Boddington; Elmstone Hardwicke; Leigh; Norton; Staverton; and Uckington in the Tewkesbury and Cheltenham Boroughs in the County of Gloucestershire.

2. In this Order -

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.

3. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule I to this Order at a speed exceeding 30 mph.
4. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule II to this Order at a speed exceeding 40 mph.
5. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule III to this Order at a speed exceeding 50 mph.
6. The Orders referred to in Schedule VI to this Order are hereby revoked.

- Old Gloucester Road (B4634) From a point 850 metres west of its junction with the centreline of Pilgrove Way (40219) to its junction with the kerbline on the northern side of the Cheltenham Road at Staverton Bridge (B4063)
- 3/82 From its junction with the kerbline on the north western side of Old Gloucester Road (B4634) for a distance of 135 metres in a westerly direction
- Withbridge Lane (40421) From its junction with the kerbline on the south western side of the Tewkesbury Road (A4019) to its junction with the kerbline on the northern side of Old Gloucester Road (B4634)
- Wainlode Lane (3/77) From a point 190 metres north of its junction with the centreline of Kings Elm (48021) to its junction with the kerbline on the north western side of the A38
