

**GLOUCESTERSHIRE COUNTY COUNCIL  
(40 & 50 MPH SPEED LIMITS)  
(A38 TEWKESBURY ROAD) (VARIOUS PARISHES)  
(TEWKESBURY BOROUGH)  
ORDER 2026**

The Gloucestershire County Council ("the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 6<sup>th</sup> February 2026 and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL (40 & 50 MPH SPEED LIMITS) (A38 TEWKESBURY ROAD) (VARIOUS PARISHES) (TEWKESBURY BOROUGH) ORDER 2026".  
  
(ii) This Order affects roads within the Parishes of Twigworth, Down Hatherley, Norton and Leigh within the Tewkesbury Borough in the County of Gloucestershire.
2. In this Order –  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.
3. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule 1 to this Order at a speed exceeding 40 MPH.
4. No person shall cause or permit any Motor Vehicle to proceed along that length of road described in Schedule 2 to this Order at a speed exceeding 50 MPH.
5. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
6. In accordance with Part IV of Schedule 9 of the Act, the following parts of Orders are to be revoked as specified in the sub-Articles that follow:

**Schedule III – 50mph Speed Limit**

A38	From a point 400 metres south west of its junction with the centreline of Coombe Hill (40442) to a point 110 metres north east of its junction with the centreline of Down Hatherley Lane (3/81)

Wainlode Lane (3/77)	From a point 190 metres north of its junction with the centreline of Kings Elm (48021) to its junction with the kerblin on the north western side of the A38.

**40mph Speed Limit to be Introduced**

Road Name & Number	Description
Tewkesbury Road (A38)	From a point approximately 96m north-east of the centreline of its junction with Down Hatherley Lane (C81) to a point approximately 92m north-east of the centreline of its north-eastern junction with Wainlode Lane (C77)
Wainlode Lane (C77)	From its junction with Tewkesbury Road (A38) for a distance of approximately 83m in a south-westerly direction.
